

According to article 36 paragraph 3 in the Law of Government of the Republic of Macedonia (“Official Gazette of the Republic of Macedonia“ No. 59/00, 12/03, 55/05, 37/06, 115/07, 19/08, 82/08, 10/10, 51/11, 15/13, 139/14,196/15 and 142/16) and article 23 point 2 of the Law for ratification of the Protocol amending the Marrakesh Agreement establishing the World Trade Organization (“Official Gazette of the Republic of Macedonia” No. 130/15), the Government of the Republic of Macedonia at the session held on 26.09.2017, adopted

DECISION
for establishing National Committee on Trade Facilitation

Article 1

With this Decision, within the Ministry of Economy is establishing a National Committee on Trade Facilitation according to the obligations in the Protocol amending the Marrakesh Agreement establishing the World Trade Organization ratified by the Law of the Protocol amending the Marrakesh Agreement establishing the World Trade Organization (“Official Gazette of the Republic of Macedonia” No. 130/15), (hereinafter referred to as: Protocol).

Article 2

The National Committee on Trade Facilitation (hereinafter referred to as: Committee) is obliged to facilitate the domestic coordination in this area and to implement the provisions of the Protocol.

Article 3

The Committee performs the obligations referred to article 2 of this Decision, in cooperation with entities competent for cross-border trading, thru appointed representatives.

With the Committee chairs the Minister of Economy.

In the work of the Committee participates representatives, as member and deputy member from the following entities:

Article 4

On the day of entering into force of this Decision, shall cease to be valid the Decision for establishing a National Committee on Trade Facilitation No. 42-3385/1 from 29 March 2016 and the Decision for amending and supplementing the Decision for establishing National Committee on Trade Facilitation No. 42-4874/1 from 14 June 2016.

Article 5

This Decision enters into force on the date of its adoption and will be published in the “Official Gazette of the Republic of Macedonia”
